

To open an individual account you need to read the Forex Terms and Conditions of Business document, fill in the individual application form and also supply the following supporting documentation if you are not listed on the UK electoral role;

- Certified/Notarized copy of your passport
- Original or certified/notarized copy of a recent utility bill

Where certified/notarized copies are required they may be certified by any of the following:

- a) An embassy, consulate or high commission of the country of issue of the document;
- b) A member of the judiciary, senior civil servant or serving police officer or customs officer;
- c) Lawyer or notary public;
- d) Actuary;
- e) Accountant holding a recognised professional qualification;
- f) Director, officer or manager of a regulated financial institution operating in UK, Guernsey, Jersey, Isle of Man or an equivalent jurisdiction;
- g) A member of the Institute of Chartered Secretaries and Administrators.

The certifier must sign and date the copied documents, printing his/her name and stating his/her position/capacity.

The certification of documents must contain suitable wording which confirms that it is a true copy of the original: An example of expectable wording would be;

'I hereby certify this to be a true copy of the original document'
